2 Parent Governors / 1 Headteacher / 1 Staff / 1 Local Authority / 7 Foundation Governors

* Foundation Governors are appointed by the Diocese of Lincoln Board of Education, the Authority Governor is nominated by the Local Authority, Parent Governors are elected by the parent body and Staff Governors are elected by the staff body of the school.

**All Governors' terms of office are 4 years.

The Circle Model of governance was adopted from 1 January 2021, this has replaced committees and all matters are now dealt with by the full Governing Body
